Aging Matters In Brevard - Programs at a Glance

Caregiver Support Services: Provides education, training, support, and respite to assist caregivers responsible for the care of a loved one age 60 and over, or grandparents caring for their minor grandchildren. Call (321) 452-4341.

Community Care for the Elderly: Provides case management services to frail seniors age 60 and over including the development of a care plan and assistance in accessing community based support services. Call (800) 963-5337.

Health and Wellness: *Bone Builders* exercise classes improve bone and muscle strength and better balance. Call (321) 631-2749. In *Living Healthy* workshops, seniors learn to self-manage chronic disease and diabetes and address fall prevention. Call (321) 806-3741.

Home Care Program: Provides companion services, assistance with housekeeping, light meal preparation, non-medical personal care, and respite services. Call (321) 639-6652.

The Kitchen: Food preparation for Meals on Wheels, Seniors at Lunch, and multiple day centers for children and adults. Private catering is also available. Call (321) 636-9901.

Meals on Wheels: Volunteers deliver a hot, nutritious meal to the home of individuals age 60 or older who are homebound by reason of illness, disability, or isolation. Call (321) 639-8770. Meals on Wheels and Seniors at Lunch clients can also request to receive **Pets on Wheels** assistance once a month. Call (321) 806-3756.

Retired and Senior Volunteer Program (RSVP): Helps match individuals age 55 and older with volunteer opportunities with local non-profit organizations. Call (321) 631-2749.

Senior TranServe: Volunteer drivers provide transportation for ambulatory non-driving seniors who need a ride to medical appointments, grocery stores, or additional destinations of their choice. Call (321) 806-3787.

Seniors Assistance Program: Offers assistance with minor home maintenance, short-term homemaking and personal care services, and legal advice for non-criminal matters on a limited basis. Call (321) 631-2744.

Seniors at Lunch: Seniors age 60 and over receive a nutritionally balanced meal, social contact, and entertainment at neighborhood dining sites located throughout the county. Transportation is available to some sites. Call (321) 639-8770.

Sunflower House: A Senior and Caregiver Resource Center offering information, referrals, training, support, and social activities located at 3125 Fell Rd. West Melbourne, FL 32904 and 3600 W. King St. Cocoa, FL 32926. Call (321) 452-4341.

Vets Driving Vets: Veteran volunteer drivers provide transportation to fellow veterans who need a ride to the VA Clinic, medical appointments, and other basic needs destinations. Call (321) 806-3787.

Section I – Caregiver Support

Older Americans Act

The Older Americans Act National Family Caregiver Support Program is administered in Brevard County by Aging Matters in Brevard. The program provides 5 basic services for family caregivers including:

- Information to caregivers about available services and resources
- Assistance to caregivers in gaining access to supportive services
- Support groups and caregiver training to help caregivers make decisions and solve problems related to their caregiving roles
- Respite care to provide temporary relief to caregivers from their caregiving responsibilities
- Consumable supplies such as medical equipment and medical supplies

To be eligible for services, you must be a family caregiver of an adult age 60 and over, a caregiver of a person with Alzheimer's disease or a related disease (regardless of age), or a grandparent or relative caregiver of a child age 18 or under.

The Sunflower House Resource Center

The Sunflower House is a Senior and Caregiver Resource Center under the umbrella of Aging Matters in Brevard. It is located at 3125 Fell Rd. West Melbourne, FL 32904. This Caregiver Support Program offers durable medical equipment, incontinence supplies, support groups, counseling, educational and training opportunities, and information and referrals for family caregivers responsible for caring for loved ones.

The Sunflower House offers programming including exercise classes, weekly movies, multiple caregiver support groups, bereavement support groups, classes and presentations for those who are impacted by cancer, and presentations on other topics important to seniors and caregivers.

The Sunflower House also runs a donation-based medical equipment bank such as wheelchairs, walkers, canes, shower chairs, and bedside commodes. Available at Sunflower House, Aging Matters Business Office at 3600 West King Street, Cocoa and through a collaborative relationship with I Love My Island at 234 East Merritt Island Causeway, Merritt Island Sunflower House also hosts a Seniors at Lunch Monday through Friday.



Grandparents Raising Grandchildren

The Grandparents Raising Grandchildren program assists individuals age 55 and over who face the challenge of raising a grandchild or other related child age 18 or younger, or a disabled adult age 19-59. The program addresses the challenges of multigenerational households by providing a setting where participants receive emotional, financial, and legal support through counseling, food support, nutritional classes, and other supportive services that improve the quality of life for these multigenerational households. Grandparents Raising Grandchildren also tackles the social issues that may affect these grandparents and grandchildren, such as incarceration, substance abuse, and financial difficulties.

Grandparents Raising Grandchildren staff and volunteers are trained to assist clients in gaining knowledge and access to services essential for parenting a child again within the new financial market and the new age of technology. The program supplies grandparents with a community network of organizations, churches, schools, and community centers that can provide families with activities which are typically low or no cost.

Services may include social/recreational activities, transportation, meals, personal care, and assistance with medications. Adult Day Care programs are licensed by the Florida Agency for Health Care Administration.

Residents may have their own room or share a room with another person. Services may include housing, meals, personal care, medication assistance, resident supervision, transportation arrangement, health monitoring, and social activities. These homes are licensed by the Florida Agency for Health Care Administration.

Assisted Living Facilities (ALFs) provide housing, meals, personal care, and supportive services to older individuals who are unable to live independently. ALFs offer private or semi-private rooms and can vary in size from one (1) resident to more than 100 residents. Some are licensed to provide extended care to residents who require more assistance so they may age in place, while other facilities are specially licensed to provide limited nursing services and mental health services. Fees vary.

Senior TranServe volunteers provide transportation for non-driving seniors within Brevard County to medical appointments, grocery shopping, social activities and other destinations of choice. Individuals requesting service must be at least 60 years old, ambulatory, and able to enter and exit the vehicle by themselves. Transportation services are provided by volunteer drivers. There is a sliding fee or donation based schedule contingent upon income. The program requires at least a 7-day advanced notice for requests. To request a ride or to volunteer as a driver, please call **(321) 806-3787**.

Vets Driving Vets volunteers provide transportation for non-driving ambulatory, low-income veterans of any age within Brevard County to the Veterans Administration Clinic in Viera, medical facilities, grocery stores, and other basic needs destinations. There is a sliding fee or donation based schedule contingent upon income. The program requires at least a seven-day advance notice. Section III – Health Care

Home Health Care

Home Health Care is a wide range of health services that can be provided in the home for an injury or illness. Home Health Care is usually less expensive, more convenient, and just as effective as care received in a hospital or nursing facility. Services may be provided on an occasional basis, on an intensive short-term basis, or on a long-term basis.

Home health care services are often provided as part of a treatment plan authorized by a physician and supervised by a registered nurse. Home care custodial services involve personal care and/or homemaking. Personal care includes help in such activities as bathing, dressing, maintaining a medication intake schedule, and assisting in prescribed therapy exercises. Homemaking includes light housekeeping, laundry, and light meal preparation.

Medicare Coverage of Home Health Care*

If an individual has Medicare, home health benefits may be accessed under the following conditions:

1. The patient must be under the care of a doctor and be getting services under a plan of care established and reviewed regularly by a doctor.
2. The doctor must certify that the patient needs one or more of the following:
 - Intermittent Skilled Nursing Care
 - Physical Therapy
 - Speech-Language Pathology Services
 - Continued Occupational Therapy
3. The home health agency providing care must be Medicare-certified.
4. The patient must be homebound, and a doctor must certify that the patient is homebound. To be homebound means the following:
 - Leaving the home is not recommended because of the patient's condition.
 - The patient's condition prevents him/her from leaving the home without help.
 - Leaving home takes a considerable and taxing effort.

A person may leave home for medical treatment or short, infrequent absences for non-medical reasons, such as attending religious services.

Home Health Agencies

Home health agencies provide nursing care; physical, occupational, speech, respiratory, and IV therapy; home health aide and homemaker/companion services; home medical equipment; nutritional guidance; and medical social services in the patient's home or place of residence. Consumers should be aware that they have the right to select the agency of their choice. The decision will include such considerations as the person's personal and medical needs, insurance coverage, pricing, and impression of the agency. Agencies are licensed through the Florida Agency for Health Care Administration.

Aging Matters Home Care provides licensed, non-medical personal care and homemaker services for Brevard County residents who are age 60 and over and for adults 21 and older with disabilities. A comprehensive in-home needs assessment is conducted and plan of care is developed. This program offers homemaker, companionship, in-home respite, personal care, and chore services. The program is licensed by the Florida Agency for Health Care Administration, license #299994290. For more information about available services, please call **(321) 639-6652**.

Nursing Homes

Skilled nursing facilities are legally classified and licensed by the State of Florida. All listed facilities provide full nursing home care to meet a variety of needs. Nursing homes differ in size and environment. All welcome inquiries and provide on-site tours and information.

The patient's physician will often be involved in the decision to be admitted to a nursing home but will not select the facility. The physician must write an order for nursing home care for those covered by Medicare or Medicaid. The patient or family should talk with families of people who are in nursing homes. Prospective nursing homes should be visited before selection. Asking questions of the nursing home staff is very important. Criteria for selection may include:

- Fees and insurance coverage
- Physical facilities and environment
- Services provided, including amenities
- Staff size and duties
- Patient to staff ratio

■ Section IV – Insurance, Legal, & Related Services ■

Medicare

This federal health insurance program is designed for people 65 and older, people of any age with permanent kidney failure, and certain persons with disabilities under 65. For more information about Medicare, contact the Social Security Administration at (800) MEDICARE (800-633-4227) or visit www.Medicare.gov.

Medicaid

Medicaid provides health coverage to eligible low-income adults, childrens, pregnant women, seniors, and people with disabilities. The program is administered by the Florida Department of Children and Families (DCF). There are several programs with different eligibility standards. To apply, contact the ACCESS Customer Call Center at (866) 762-2237 or visit www.myflorida.com/accessflorida.

The Department of Children and Families determines financial eligibility for Medicaid, nursing home, and assisted living placement. There are other programs designed to help the medically needy that have varying eligibility requirements and benefits. These include programs that help pay Medicare premiums and Medicare coinsurance requirements and deductibles.

Guardianship

Legal guardianship is the process whereby the court appoints a guardian to be legally responsible for the management of another person's care, finances, and property because that person is incapacitated. Emergency guardianship proceedings are available in cases involving imminent danger to the ward or improper utilization of personal or financial assets. The Statewide Public Guardianship Office, housed within the Florida Department of Elder Affairs, appoints local public guardian offices as directed by statute to provide guardianship services to persons who do not have adequate income or assets to afford a private guardian and there is no willing family or friend to serve. The Statewide Public Guardianship Office is also responsible for the registration of Professional Guardians. To speak with a Public Guardian in Brevard County, contact Aging Solutions at (321) 768-7997.

Insurance Assistance/Counseling - SHINE

SHINE (Serving Health Insurance Needs of Elders) offers free Medicare and health insurance education, counseling, and assistance to individuals with Medicare and their families and caregivers. SHINE is administered by the Florida Department of Elder Affairs and funded through a grant from the Centers for Medicare and Medicaid Services. Trained volunteers provide counseling and information on Medicare, Medicaid, Medicare supplemental insurance, long-term care insurance, prescription assistance, and Medicare fraud.

There are SHINE offices located throughout Brevard County. Adult Protective Services (“APS”), under the State of Florida, Department of Children and Families, is responsible for the Investigation of Abuse, Neglect and Exploitation of any person, over the age of 18, who has an impairment that effects their ability to provide for their own health and safety, when the abuse occurs in the State of Florida. Anyone in the State of Florida that suspects an adult is being abused, neglected or exploited should contact the Florida Abuse Hotline at 1-800-96-ABUSE (1-800-962-2873). APS also provides assessment and referral services to adults seeking information about community programs. It is the goal of APS to assist community members to remain independent and safe in their chosen living environment, and to assist in finding services to support this independence.



On **June 15th** each year, participants celebrate World Elder Abuse Awareness Day (“WEAAD”). In communities around the world, people come together to discuss how to educate and focus attention on the problem of Elder Abuse. In Brevard County, DCF Adult Protective Services, the Brevard Commission on Aging, Brevard Alzheimer’s Foundation, and the Brevard TRIAD bring together community service partners and vendors to a Senior Festival, at the Melbourne Auditorium, to highlight and provide information and services to our community regarding this issue. The event focuses on enabling our seniors and disabled population to remain independent within our community and showcases services and products to support independent living. The WEAAD committee also sponsors quarterly seminars, to educate citizens and service providers on current issues. All WEAAD events are free to the general public. All are invited to attend, learn more about this global issue, and what is being done in our local communities.

Section V – Financial

Estate Planning

Last Will and Testament

A Last Will and Testament is used to designate distribution of a Decedent's assets to the Decedent's heirs. It is a tool to ensure that an individual's property passes in accordance with the individual's wishes. To be valid, a will must meet specific requirements, and therefore, legal advice is recommended. If a person dies without a will, the property is passed in accordance with inheritance laws.

Probate

Probate is a court-supervised process that examines the authenticity of a will, identifies and gathers the assets of a deceased person, decides who is to receive the deceased person's property, and pays the decedent's debts. Then the judge will appoint a "personal representative," if one has not been named in a valid will, who will distribute the decedent's assets to his or her beneficiaries at the conclusion of the probate. The original will must be deposited with the Probate Court within 10 days of the decedent's death. In almost all cases, a qualified attorney should be engaged for Florida probate.

Estate Taxes

An "estate tax" is a tax on the estate (property/assets) of the deceased person. The taxable estate is the gross amount minus deductions. The federal estate tax is reduced by a credit for the amount of the Florida taxes paid. This should not be confused with an "inheritance tax" which is a tax imposed on the receiver of an inheritance. There are no inheritance taxes in Florida.

Trusts

A Trust can accomplish everything that a will can do but has some advantages over a will. The biggest advantage to a Trust is that it avoids the cost and complication of probate, allowing your successor to quickly and easily administer your estate without sacrificing any control or flexibility while you are living. A will takes effect only upon your death, but a Trust is effective upon creation. Because a Trust takes effect during life, it has various advantages: (1) a Trust provides for the grantor's incompetence without the complications of guardianship; (2) a Trust remains a private family matter and is not a part of public record; (3) a Trust is freely changeable and revocable during the grantor's lifetime; (4) a Trust can include provisions to reduce or eliminate Federal Estate Taxes; and (5) Assets owned by a Trust are not subject to probate, thus reducing the cost and delays of administration, unlike a will.

■ Section VI – Funeral & Cremation Services ■

The death of a loved one sets in motion a difficult and sometimes complex process. Ideally this process will have been planned for by the decedent before the fact, utilizing the “pre-need” services of a funeral home, or through prior counseling on the process from service providers. The laws governing this process are complex and are governed through comprehensive regulations.

Outline of Process

1. Death Occurs

If death occurs at home, call 911. The local Police Department or Sheriff’s Department will send an officer who will observe the situation, interview the caller, and complete a formal report of the circumstances. The police officer will make all necessary calls for the family and will ensure that all reports are filed. If death occurs in a hospital or at home under Hospice care, that organization normally will take the necessary first steps.

2. Medical Examiner

The Medical Examiner (office in Rockledge) must sign the death certificate attesting to the cause of death. Normally the Medical Examiner will do so without examination of the deceased if an attending physician is available to sign the death certificate. The police officer will contact the attending physician and/or the Medical Examiner.

3. Funeral or Cremation

Ideally a funeral home or firm will be selected before the fact. The firm should be called as soon as possible after death. The police officer, hospital, or hospice will make the call if indicated.

The Brevard County Housing and Human Services Department, Community Resources Action Team, may provide funds for cremation assistance for an indigent person who has no relatives or resources who can assume the responsibility.

4. Death Certificate

For any person who dies in Brevard County, a death certificate is filed with the county's Vital Statistics Office. Copies are available for a fee. A death certificate is required for insurance and legal processes. Many times a funeral home will make arrangements for certificates to be purchased for the family. In addition, death certificates may be requested in person at the Department of Health, 2575 N Courtenay Pkwy Ste 104, Merritt Island, FL 32953. You must specify if you want the cause of death listed on the certificate. Certificates may also be requested by sending a letter to the above address with a check made out to the Brevard County Health Department for the appropriate fee for each certificate. For further information, call the Vital Statistics Office of the Brevard County Health Department at (321) 454-7163.

Brain Bank

To confirm a diagnosis of Alzheimer's disease, a brain autopsy must be completed. Families may pre-register with the State of Florida Brain Bank to receive the autopsy at no cost. The family must agree to provide tissue for Alzheimer's research as well as provide information for pathological studies. The autopsy program provides valuable information to continue the research on Alzheimer's disease.

Section VII – Equipment and Devices

Durable Medical Equipment

Sunflower House

The Sunflower House, located at 3125 Fell Road, West Melbourne offers a medical equipment bank for community members and family caregivers. The equipment bank accepts donations of wheelchairs, walkers, canes, shower chairs, and bedside commodes clean and in good condition, as needed, and loans this equipment to individuals both short and long-term. The medical equipment is available at no cost to eligible seniors and caregivers; however, the Sunflower House depends upon donations to help offset the cost of running the program. Call the Sunflower House at (321) 452-4341 to schedule an appointment to donate or borrow equipment.

Space Coast Center for Independent Living (SSCIL)

The Space Coast Center for Independent Living (SSCIL) accepts donations and then loans out durable medical equipment such as wheelchairs, walkers, canes, crutches, bedside commodes, scooters, etc. until permanent equipment can be obtained. Call (321) 806-3199. **

Other local organizations provide medical supplies and many offer light medical equipment such as crutches and walkers. Several Brevard businesses such as pharmacies, medical clinics, hospitals, and nursing homes also provide durable medical equipment, such as wheelchairs and beds, for consumers' use in the home. Project Lifesaver Program

The State Attorney's Office and the Brevard County Sheriff's Office created Brevard County TRIAD, Inc., a partnership between many different organizations tasked with identifying and developing programs to address the needs and concerns of seniors in Brevard County such as personal safety, health concerns, and transportation needs.

One such program is the Project Lifesaver Program which provides individuals with a personalized radio transmitter bracelet. When an individual is reported missing, trained law enforcement locate the transmitter signal using both air and ground tracking receivers. This proven radio technology has enabled quick recovery times. Applications for the Project Lifesaver bracelets are processed through the Brevard County Sheriff's Office Community Services Unit and are available by calling (321) 264-7755 or by downloading brochures and applications at www.BrevardTriad.org.

Section VIII – Veterans Affairs

Veterans of the U. S. Armed Forces may be eligible for a variety of services provided by the Department of Veterans Affairs (VA). Eligibility for benefits is based on dates of service, status at the time of discharge, service related injuries, and a variety of other conditions specific to the assistance requested. The VA offers health care services, services for veterans with service-connected disabilities, pensions, education and training, home loans, life insurance, burial and memorial benefits, and transition assistance.

VA Clinic at Viera

Brevard County is also home to a 107,000 square foot outpatient clinic. The clinic provides both primary and specialty care including outpatient surgery, psychiatry, physical medicine and rehabilitation, neurology, orthopedics, dentistry, geriatrics, radiology, and Tele-Care Services.
